REGISTRATION OF BUSINESSES ACT 1956

REGISTRATION OF BUSINESSES (WAIVER OF FEE) RULES 2016

IN exercise of the powers conferred by paragraph 16(2)(j) of the Registration of Businesses Act 1956 [Act 197], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Registration of Businesses (Waiver of Fee) Rules 2016**.

(2) These Rules come into operation on 15 March 2016.

Waiver of fee

2. The fees prescribed in subitems 5(f) and (g) of the Second Schedule to the Registration of Businesses Rules 1957 [L.N. 282/1957] are waived in respect of any Federal Government agency and Federal statutory body.
