In 2018, Suruhanjaya Syarikat Malaysia (SSM) introduced the **MALAYSIAN BUSINESS REPORTING SYSTEM (MBRS)** – a project to develop digitalized companies' financial reporting and annual return based on the eXtensible Business Reporting Language (XBRL) format for the purpose of compliance with the requirement contained in the Companies Act 2016.

Corporate Tea Talks

In January 2018, COMTRAC and Knowledge Management Division organized the first **Corporate Tea Talk** on 'Malaysian Business Reporting System' in Kuala Lumpur. This two-hour awareness programme intended to introduce XBRL and the scope of submission under MBRS. A total of 10 Corporate Tea Talks were organized Malaysia-wide from January to July 2018 and were attended by more than 2,100 stakeholders.

At the same time, more than 144 **Corporate Tea Talks (State Levels)** on 'Malaysian Business Reporting System' were offered by SSM State Offices and Branches from March to September 2018.
