

COMPANIES ACT 2016: PRACTICE NOTE NO. 6/2024

NOTIFICATION ON THE APPROVAL AS AN APPROVED LIQUIDATOR UNDER SUBSECTION 433(4D) OF THE COMPANIES ACT 2016

1. This Practice Note is issued pursuant to section 20C of the Companies Commission of Malaysia Act 2001.

OBJECTIVE

2. This Practice Note serves to guide a person on the requirement to notify the Registrar upon being approved as a liquidator.

BACKGROUND

3. Subsections 433(4D) and 433(4E) of the Companies Act 2016 requires any person who has been approved as a liquidator to notify and update certain information to the Registrar.

4. These provisions were enacted via the Companies (Amendment) Act 2024 and is in line with the Guidelines for Approval of Liquidator issued by the Accountant General's Department of Malaysia.

5. Para 5.6 of the Guidelines for Approval of Liquidator requires a person who have received the Certificate of Approval as an approved liquidator to –

- (a) notify the Registrar within 30 days from the date of issuance of the certificate; and
- (b) update any information within 14 days from the date of changes.

SECTION 433(4D) - REQUIREMENTS TO NOTIFY THE REGISTRAR ON THE APPROVAL AS AN APPROVED LIQUDATOR

6. Subsection 433(4D) of the CA 2016 states that any person who has been approved as a liquidator to notify the Registrar within 30 days from the date of approval the following particulars:

- (a) The personal information of the approved liquidator;
- (b) The date of approval as an approved liquidator;
- (c) The firm of the approved liquidators, including partners of the firm and branches, if any; and
- (d) Any other particulars required by the Registrar.

7. In this regard, upon receiving the Certificate of Approval as an approved liquidator, the approved liquidator must lodge with the Registrar the following information:

- (a) Personal information of the approved liquidator, including –
 - (i) Full name;
 - (ii) Identity Document (ID) Type;

- (iii) National Registration Identity Card (NRIC) Number;
- (iv) Nationality;
- (v) Gender;
- (vi) Race;
- (vii) Residential address;
- (viii) Phone number; and
- (ix) Email address.
- (b) Information on the approval as an approved liquidator, including –
 - (i) Letter/certificate of approval issued by the AG;
 - (ii) Liquidator's approval number; and
 - (iii) Validity period of Liquidator's approval.
- (c) Information of the firm of liquidators, including -
 - (i) Type of firm;
 - (ii) Firm's name;
 - (iii) Firm's number;
 - (iv) Date of admission as partner/sole-proprietor/Date of commencement of business;
 - (v) Office address;
 - (vi) Office phone number;
 - (vii) Office email address;
 - (viii) Particulars of partners, if any; and
 - (ix) Particulars of branch, if any.

8. Information under paragraph 7 shall be lodged through the form attached in **Appendix 1**.

REQUIREMENTS TO UPDATE ANY INFORMATION WITH REGARDS TO THE NOTIFICATION

9. Subsection 433(4E) of the CA 2016 requires any changes in the particulars of the firm or details of its partners to be notified to the Registrar within 14 days from the date of such changes.

10. The approved liquidator shall lodge the updated information along with the date of changes to the Registrar using the **Appendix 1**.
