COURSE INTRODUCTION

In response to the COVID-19 pandemic, many organizations have shifted to Work From Home for the foreseeable future and some are operating with 60% to 50% staff working from home. It creates a situation ripe for cybercriminals and nation-state actors to exploit and we have been witnessing 600% raise in attacks as reported by many major cybersecurity threat reports. Security best practices often take a back seat to business continuity in strange times like these. Teams that previously managed a primarily in-house workforce are not prepared to combat new threats from a workplace without defined borders.

For security teams, the sudden change in an organization's network topology means a vastly expanded attack surface with little time / no time and additional security budget provided to adapt to the new reality. For employees, generally, it means having to be even more vigilant of potential attacks while all work is done via remote working and online meeting platforms.

This course will introduce the security threats of remote working with Live demos and highlight the various defense and mitigation measures to keep the organization secure and cyber resilient.


