1	What is the date of the conference?	<p>The SSMNC2026 has 3 options as below:</p> <ul style="list-style-type: none"> a) 18 – 19 August 2026 – Virtual via Zoom. b) 18 – 19 August 2026 – In-Person at KLCC. c) 18 – 20 August 2026 (+ master class) – In-Person at KLCC <p>Delegate can ONLY register for 1 option as above and will not be allowed to change the option after registered.</p>		
2	Where is the venue for In-person conference?	<p>The In-Person conference will be held at Kuala Lumpur Convention Centre (KLCC), Kuala Lumpur City Centre, 50088 Kuala Lumpur.</p>
