KAEADAH-KAEADAH PENDAFTARAN PERNIAGAAN (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 16 Akta Pendaftaran Perniagaan 1956 [Akta 197], Menteri membuat kaedah-kaedah yang berikut:

Nama

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Pendaftaran Perniagaan (Pindaan) 2020.**

Pindaan kaedah 14

2. Kaedah-Kaedah Pendaftaran Perniagaan 1957 [L.N. 282/1957], yang disebut "Kaedah-Kaedah ibu" dalam Kaedah-Kaedah ini, dipinda dalam Kaedah 14 dengan memasukkan selepas perenggan (e), perenggan yang berikut:

"(ea) obtain a copy of a business profile;".

3. Butiran 5 Jadual Kedua kepada Kaedah-Kaedah ibu dipinda, dalam ruangan *Matter*, dengan memasukkan selepas subbutiran (e) dan butir-butir yang berhubungan dengannya subbutiran dan butir-butir yang berikut:

REGISTRATION OF BUSINESSES ACT 1956

REGISTRATION OF BUSINESSES (AMENDMENT) RULES 2020

IN exercise of the powers conferred by section 16 of the Registration of Businesses Act 1956 [Act 197], the Minister makes the following rules:

Citation

1. These rules may be cited as the **Registration of Businesses (Amendment) Rules 2020**.

Amendment of Rule 14

2. The Registration of Businesses Rules 1957 [L.N. 282/1957], which are referred to as the “principal Rules” in these Rules, are amended in Rule 14 by inserting after paragraph (e), the following paragraph:

“(ea) obtain a copy of a business profile;”.

Amendment of Second Schedule

3. Item 5 of the Second Schedule to the principal Rules is amended, in the column *Matter*, by inserting after subitem (e) and the particulars relating to it the following subitem and particulars:

	“(ea) a copy of a business profile by—	
(i)	any ministry, department or agency of the Federal Government;	Nil
(ii)	any other person	10.00 per copy”
