



#### A. About e-Secretary

#### What is e-Secretary?

e-Secretary is an online application provided by SSM for registration to act as a secretary which is a requirement under section 241 of the Companies Act 2016.

- Upon approval of the application, practising certificate will be issued by SSM and the particulars of the approved applicant will be entered in the Register of Secretaries.
- The application is accessible via https://esecretary.ssm.com.my/ for 24 hours a day and 7 days a week.
