LIMITED LIABILITY PARTNERSHIPS ACT 2012

LIMITED LIABILITY PARTNERSHIPS (WAIVER OF FEE) REGULATIONS 2020

IN exercise of the powers conferred by paragraph 91(1)(b) of the Limited Liability Partnerships Act 2012 [Act 743], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Limited Liability Partnerships (Waiver of Fee) Regulations 2020**.

**Waiver of fee**

2. The fee prescribed in item 13 of the Schedule to the Limited Liability Partnership Regulations 2012 [P.U. (A) 462/2012] is waived in respect of an application received from any ministry, department or agency of the Federal Government.
